

Rev. Lori Beth's Message

"On that day, when evening had come, he said to them, 'Let us go across to the other side.' And leaving the crowd behind, they took him with them in the boat, just as he was. Other boats were with him. A great gale arose, and the waves beat into the boat, so that the boat was already being swamped. But he was in the stern, asleep on the cushion; and they woke him up and said to him, 'Teacher, do you not care that we are perishing?' He woke up and rebuked the wind, and said to the sea, 'Peace! Be still!' Then the wind ceased, and there was a dead calm. He said to them, 'Why are you afraid? Have you still no faith?' And they were filled with great awe and said to one another, 'Who then is this, that even the wind and the sea obey him?"- Mark 4:35-41

One of my favorite scripture images is that found in Mark 4:35-41 of Jesus calming the storm. I think it is a powerful image that speaks about our life experiences. As people of faith, there are times when we will experience turmoil, the waves beating against us. God shows us that during the storms of life we are never alone. St. Paul's United Church has weathered many storms over the years and has experienced many positive changes. There is a great energy here and we are experiencing growth. The Holy Spirit is in this place.

In July 2012, St. Paul's experienced another change in welcoming me as your new Minister and welcoming my husband James. It was a change for us to move from a rural multi-point pastoral charge to a large city church. It is hard to believe that 6 months have passed. I still remember clearly my first Sunday Service with you on August 5th 2012. It is a humbling experience to preach from the pulpit of St. Paul's with the congregation sitting both in the balcony and below. My knees were shaking that first Sunday. It didn't take long to experience hospitality and to be welcomed into the caring community that is St. Paul's.

The Holy Spirit continues to work through and with the congregation of St. Paul's. We are acting as the hands and feet of Christ through programs like the Brown Bag Lunch, the Pantry, operating affordable housing apartments and hosting congregation building events such as fellowship dinners. This is a congregation that has a spirit of wanting to reach out to the wider community and to grow closer to Christ. I am blessed to be able to serve a community who reaches out to others.

This has been a busy year. I represented St. Paul's at the 41st General Council in August. I was able to network with clergy and laity from across the country. It was a powerful experience to vote and make decisions about our United Church. Locally I have participated in the roundtable discussions on poverty through the "Better Together" initiative. I was a guest speaker at the Prayer Service for the National Day of Remembrance and Action on Violence Against Women. I have also been involved with some of the interfaith activities such as the Prayer and Carol Walk before Christmas.

We've had some successful events at St. Paul's. It is amazing what can happen when we as individuals come together. The Advent Carol Festival was a wonderful event which saw the sanctuary filled in support of the food bank. At our Christmas Eve services we had great turnouts to worship the Christ Child.

We may face some rough times ahead in the waters of life, but I am confident that St. Paul's has a bright future and will continue to be a beacon of hope in our society. I am excited for what the future may bring for St. Paul's and may we continue "to act justly and to love mercy and to walk humbly with our God". – Micah 6:8

Constitution of Court:

David Thorne, on behalf of Blaine Irving, Chair of the Congregation, called the meeting to Order.

Devotions: Reverend Dr. Peter Short opened the meeting with prayer.

Adoption of Agenda: It was moved by Alan Rayner and seconded by Lynne Naugler that the Agenda be adopted as circulated. Motion carried.

Minute of Silence as Reverend Dr. Peter Short read "In Memoriam"

- Motion for Time of Adjournment: Moved by Malcolm MacFadyen and seconded by Tammy Coughlan that the meeting should adjourn by 1:00 p.m. Motion carried.
- The Chair advised that the meeting was being held in Accordance with the provisions of the Manual Section 5.8.3 of the Basis of Union and Section 113 of the By Laws.
- Nominations and Elections for the Positions of Chairperson and Secretary: moved by Ron Naugler and seconded by Alan Rayner that Blaine Irving be elected Chair and Jane Blakely be elected Secretary. There being no further nominates the incumbents were acclaimed.
- Adoption of Minutes of Annual Meeting of February 20th 2011: Moved by Jane Blakely and seconded by Harold Raper that the Minutes be adopted as presented. Motion carried.
- Adoption of Annual Report: Moved by Jane Blakely and seconded by Ed Bujold that the Annual Report be adopted as circulated. Motion carried.
- Correspondence: Secretary Jane Blakely reported that there was no correspondence.
- Nomination and election for vacancy on Ministry and Personnel Committee: Moved by Ross Mathers and seconded by Bill Paterson that Hope Brewer be elected to Ministry and Personnel for a two year term. Motion carried.
- Review of 2011 year end finances (unaudited): Treasurer Glen Sheppard moved acceptance of the Financial Statement as presented. Seconded by Ron Naugler. Motion carried.

- Review of 2011 Restoration Committee activities/ pending work: Committee Chair Mary Dingee Jacobs reported on the fundraising work of the Restoration Committee in 2011. She thanked the donors and fundraisers for their support. Alan Rayner, Chair of Trustees, advised that there will be the need for approximately \$600,000 more work on top of the \$550,000 spent to date. The longer the work is left, the more it will cost.
- St. Paul's Foundation proposal: Moved by Mary Dingee Jacobs and seconded by Bud Bird that the Congregation direct the establishment of the St. Paul's Foundation. The St. Paul's Foundation would have three goals:
- Raise and sustain capital funding to maintain the physical and architectural integrity of St. Paul's;
- Assist in operational issues from time to time with funding and administrative support as resources permit;
- Offer the membership of St. Paul's the opportunity to be involved in the church's mission.

A Board and a group of champions (with approximately 25 members) would lead the Foundation. This would replace the Restoration fund. The motion carried unanimously.

Joint Search Committee update: Ralph Simpson advised that the committee is at the interview stage. Although the mandate is 1.75 FTE the committee is focusing on finding one FTE at this stage.

Committee reports Q & A: - Committee Chairs

Review of pending building maintenance issues: Property Committee Co-chair John Hart and Trustees Chair Alan Rayner reported that the furnace is continuing to be a big problem as pipes are plugged and valves stuck open or shut. The relatively new boiler is failing because it has to work so hard to circulate the water.

Manse conversion proposal: Alan Rayner presented a proposal to convert the Manse property to a multiple unit rental property. The Financing looks feasible with \$160,000 (for a 4 unit) of potential (grant) funding from the Province and a mortgage on the Turner property for the balance of the estimated \$275 – 290,000 cost. It was moved by Lynne Naugler and seconded by Carol Peacock that:

Be it resolved that on the recommendation of the Trustees and the Congregational Board, the congregation of St. Paul's approves the conversion of the property at 242 York St. (known as "the Manse") into a multiple unit rental property.

The Motion carried unanimously.

- Adoption of Budget for the year: Treasurer Glen Sheppard presented the proposed budget for 2012. Ron Naugler pointed out that there is the need for a financial stewardship committee to promote PAR, envelopes, wills and the donation of securities. Moved by Glen Sheppard and seconded by Darryl Bruce that the Budget be adopted as presented. Motion carried.
- Appointment of Treasurer: Moved by Ron Naugler and seconded by Alan Rayner that Glen Sheppard be appointed as Treasurer for 2012. Motion carried.
- Appointment of EPR Daye Kelly & Associates: Moved by Ron Naugler and seconded by Harold Raper that EPR Daye Kelly & Associates be appointed to conduct the Financial Review for the year ending December 31, 2012. Motion carried.
- Adjournment: Moved by Reverend Dr. Peter Short and seconded by Tammy Coughlan that the meeting adjourn at 12:57 p.m. Motion carried.

Benediction: Reverend Dr. Peter Short closed the meeting with prayer.

Property Committee 2012 Annual Report

The Committee completed its second year of existence and there were some changes in the member lineup. Members are Bob Blakely, Ann Gale, John Gaskin. Derrick Grant Vice Chair, Kyle Mathers Vice Chair, Harold Raper and Greg Morton (Chair)

Work Completed in 2012

- Spring clean-up day May 19 was a success with a good turn out and much work done.
- The Sanctuary heating/ plumbing system was our high priority this year and was completed at a cost of \$20,000+. This project took up most of our budget for 2012
- The following were included in our painting work, two of the offices, a Sunday school classroom, the outdoor shed, the main floor men's washroom, the hall from the ladies parlour, the area going from the office to the Sanctuary and most of the brown doors using the new color scheme recommended by an interior decorator
- The wall base of the Choir room was painted
- The repair of the ceiling and wall in the west balcony was completed by Harold Raper and John Gaskin (saving us over \$10,000 as per a contractor quote) and other balcony wall and ceiling touch ups were done
- Repaired the caulking, repaired and painted the outer door behind the organ
- Repainted the parking lot divider lines
- The Fraser Hall kitchen floor was stripped and waxed
- A much needed new carpet was installed in the Sanctuary
- The Church and Hall alarm systems were reviewed and updated
- An updated Emergency Evacuation plan was put in place
- New outside sand boxes were built and painted
- Commenced repairing the nicks and gouges in the woodwork in the Narthex and Sanctuary and will continue this delicate and arduous work
- The Company Masontech was requested to inspect and review their December 6, 2002 Masonry Condition report in order we can set our Restoration priorities for the future and their report is expected shortly.

Property Committee

Work for consideration in 2013

- Repair the Hall roof as there is leaking in certain rooms of Fraser Hall. Quotations were obtained for resurfacing the roof (\$80,000). High priority
- Repair the Fraser Memorial Hall soffit and fascia and install a rain gutter, quotes are being requested -high priority, will depend on budget availability
- Insulate the area above the Fraser Memorial Hall ceiling and the roof-medium priority after roof and soffit/rain gutter projects are completed-medium priority
- The YMCA room Windows will be repaired after the roof and soffit projects are completed -high priority for spring
- Strip and varnish the Fraser Memorial Hall floor will be done in 2013 if the budget permits
- Repair the George Street Fire Escape-medium priority
- Repair the roof over the entrance to the boiler from the George St parking lot –medium priority
- Repair and paint Sanctuary storm window frames and sills, delayed until spring-low priority
- Asphalt the walkway between George Street and Charlotte St parking, to be considered with Manse project-low priority
- Asphalt the Turner House parking lot, to be considered with Manse project-low priority
- The choir loft area will be painted at a later date-low priority
- Upper Room storage area to be cleaned up-low priority
- Clean up Church basement-low priority

We work closely with the Sexton and we are pleased with our new Sexton Joe Robicheau's progress to date

We will diligently continue the maintenance and upgrade of the Church, Fraser Hall and the Turner and Manse properties

We encourage St. Paul members to pass along any deficiencies, ideas or suggestions to the Committee

ST PAUL'S UNITED CHURCH FINANCE COMMITTEE REPORT 2012

The accounting system at St Paul's has separate ledgers for The Church Building and Fraser Hall Operations, The Restoration Fund, The Housing Operations, Trust Funds and Capital Fund.

The finance committee's responsibilities include monitoring the financial affairs of St Paul's on a regular basis and in a professional manner.

The committee works closely with all committees in our Congregational Organization and with our Board representative Blaine Irving.

It is also our responsibility to offer financial advice and provide recommendations to the various committees and the Board. As chair of finance I am one of three signing officers for cheques and other documents!

During the year we met 5 times to review the church's financial operations and financial position.

We work very closely with Cathy Simpson, office administrator and as a committee member to provide timely, accurate and meaningful financial information. We regularly compare the actual income and expenditures for each month and year to date with the 2012 budget and offer suggestions for financial and operating improvements.

We also review the accounting procedures and controls and suggest improvements.

Although we are not responsible for Stewardship we do encourage your regular givings. Please continue to use church envelopes and you are **encouraged** to join PAR.

Givings to the OPERATING ACCOUNT for the year were less than we budgeted for 2012! .THANK YOU for your continual financial support to St Paul's!!

St. Paul's United Church Board of Trustees Annual Report for 2012

The Board of Trustees held 7 meetings throughout 2012. One of the benefits of the new governance model is that it has reduced the need for Trustees to meet as frequently as required in previous years.

The Board currently consists of the following individuals: Mary Dingee-Jacobs, Royal MacDonald, Bill Paterson, Ron Naugler, Frank Goddard, Malcolm MacFadyen (life member), Alan Rayner (Chairman). The Ex-Officio members being: Rev. Lori-Beth Sheffield-Bowles, Cathy Simpson (Secretary) and Glen Sheppard (Treasurer). Bill McNamara is the Congregational Board representative to Trustees.

Although the work load has been reduced under the new governance model, Trustees are still tasked with having the authority and responsibility for the church's assets, acquisitions and disposals. The Property Committee, reporting directly to the Congregational Board, has now undertaken a lot of the maintenance and repair work that had been previously done by the Board of Trustees.

Greg Morton, Chair of the Property Committee, has identified in his annual report a list of minor and major repair work undertaken in 2012. He has also identified work that his committee is recommending to be undertaken in 2013, or as soon as funding is available Trustees will be working with the Property Committee in developing a long term plan around the maintenance and preservation of the church.

Mary Dingee-Jacobs, Chair of the Restoration Committee, has also been working hard to try and raise the necessary funds to undertake extensive masonry and other restoration repairs needed. Her report will identify the results of her committee's efforts and the strong congregational financial support she has received to date.

The Board of Trustees thank both Mary and Greg along with their committee members for all of the hard work they are putting in on behalf of St. Paul's. I know John Gaskin and John Hart among others have also completed a lot of repair work behind the scenes in the last year. A special thanks to Harold Raper for looking after the Turner House rental, and Harold and John Gaskin for repairing the balcony ceiling above the door in the sanctuary. Their work alone has saved the church several thousand dollars. Thanks to others not mentioned who give so freely of their time!

The YMCA After School Child Care Program continues to be a positive community and church activity that addresses a need in the community, and is a part of our outreach in introducing young families to the church. It also continues to be a source of annual revenue for the church.

In November 2011, Trustees entered into its third roofing contract with Boudreau Sheet Metal Ltd., Moncton. This third contract was to undertake repairs to the copper roof over the George Street parking lot stairs. The value of the contract was \$45,632. The contractor started work in November and after stripping the old copper and placing a thin weatherproof membrane material to make ready for the new copper, they left the job. However, Trustees were able to make arrangements to obtain the copper required to complete the work and to get the contractor back in early March to successfully complete the job by mid April.

Building on the success of the Turner House project in assisting households in need of affordable housing, the Board of Trustees sought and received Congregational and Presbytery approval to undertake the conversion of the former Manse into a four unit rental apartment. This process was started in January 2012. Although it has been a long difficult process, as a result of a number of setbacks encountered along the way, the positive results are quite visible with the work that has been ongoing since November. We received three bids on this project and were fortunate to be in a position to award the contract to E & R Toner Renovations Ltd., for an amount of \$294,930. As a result of negotiations and good co-operation from the contractor, we were able to realize an approximate \$30,000 reduction from the original bid.

Some of the setbacks did increase our costs slightly and delayed the project several months, however we are fortunate (as of the date of this report) that we are within budget and the project is scheduled to be completed on time and ready for occupancy by May 1, 2013.

There will be two - two bedroom units for families and two - one bedroom units for non elderly singles. As well, two of the four units will be wheelchair accessible. Because our project is targeted for households in need of affordable housing, the project has been approved for a Federal/Provincial housing grant representing about 46% of the actual cost of the project.

In Summary:

The Board is grateful for the continued financial support it receives from the various church groups such as: the UCW, St. Paul's Quilters, and other church groups. As well, we appreciate the many donations made to St Paul's in memory of loved ones and to those remembering St. Paul's in other ways, thank you all!

I would like to again acknowledge Cathy Simpson for her diligent work and leadership in the day-to-day office administration of the church, and Alexis Ervin for her music. Thanks to Joe Robicheau, our Sexton, for his work in keeping the church clean and tidy and in helping out in many other ways.


