

WARK /ST. PAUL'S SCHOLARSHIP

INFORMATION

The Wark/St. Paul's Scholarship Funds were established from money donated by the estate of Honourable Senator David Wark who was active in the political life of New Brunswick and the congregational life of St. Paul's and from other donations to the church for the post-secondary education of its youth.

Scholarships may be awarded annually to a student enrolling or enrolled at the University of New Brunswick and other post-secondary institutions. The recipient(s), number of scholarships awarded, and their value (range \$200 - \$500) will be determined by a Scholarship Committee consisting of a duly appointed member of St. Paul's Christian Education Committee and of its Board of Trustees who make its recommendation to the Board. Decisions regarding the awarding of any scholarship are final; in any year, there may be no scholarship awarded.

ELIGIBILITY

- Applicants must be members or adherents of St. Paul's who are pursuing post-secondary studies.
- Although candidates in any year of study may apply, preference will be given to students entering their first year.
- Candidates must have been accepted as students in a recognized program at the University of New Brunswick (Wark Scholarship) or other post-secondary institution. The program may involve any field of study.
- Proof of registration in the program of study will be required before funds are distributed. Study must take place at an institution recognized by Canada Revenue Agency. Applications must be received on or before July 31

PLEASE NOTE:

- In order to comply with Canada Revenue Agency regulations concerning the disbursement of funds from registered charities (i.e. St. Paul's United Church), the cheque for the successful candidate must be payable to the institution where the candidate is studying, not to the individual. Where tuition has already been paid, the successful candidate may wish to contact the institution's financial department.
- Scholarship recipient(s) will be required to provide his/her Social Insurance Number (SIN) and a permanent mailing address when requested by the Scholarship Committee. St. Paul's United Church will issue the recipient a T4A slip for income tax purposes. Candidates do not need to provide a Social Insurance Number at the time of application.

C. Identify the institution where you plan to study and the program you have chosen

D. In 100 words or fewer, explain how/why you made these choices

Please attach **proof of acceptance** from the institution where you plan to study. The institution must be one recognized by Canada Revenue Agency: <https://www.canada.ca/en/employment-social-development/programs/designated-schools.html>

Applications must be received on or before **July 31**.

Incomplete applications **will not be** considered.
