

A Message from Rev. Michelle

The United Church put forth calls to Deep Spirituality, Bold Discipleship and Daring Justice. This year we have been *bold* to name the challenges that face our congregation. It takes courage to look at and acknowledge the struggles we face. It takes even more courage and faith to acknowledge that the course we are on is heading to death of the congregation. It takes tough and deep spiritual work to say goodbye to what has been and be open to what is coming. As we grieve our losses, there is comfort in the fact that God is always working to bring life out of death. Given the central story of our faith, it should be little surprise that across church history, time and time again, what appears to be death is just God pruning to bring forth new life, resurrection moments!

Where I saw roots of this new life taking form include:

- Evening bible study: where we are deepening our spirituality and wrestling with what it means to be disciples in today's world, and the strength provided for facing life's challenges.
- Engagement of some newer younger members such as our small Sunday school, the fall church supper, and new faces helping with fellowship coffee time.
- Energy of the Spirit sensed during some of the Downtown Untied discussions, where people had an
 opportunity to dream about a flourishing ministry. The energy seen as individuals moved through the initial
 shock of the Board and Trustees recommending selling our building to imagining what Ecumenical Shared
 Ministry might look like.
- The group of people who are visiting members who struggle to engage in person with the congregation.

I am very grateful to the congregation for the time provided for me to take a sabbatical this summer. Thank you for the much needed time for reading, research, and rest. Both my continuing education, and sabbatical time were spent learning about churches in transition, and flourishing congregations. The general themes from the reading, research, and interviews with other ministers included:

- 1) That flourishing congregations were active in pursuing and deepening their faith, regardless of how that manifested. There were opportunities to tap into the Divine through faith and spiritual practices.
- 2) There was not one cookie-cutter "thing" that people did to be vital, but rather it was a mindset that God was directing them towards X and that X aligned with the passions of the people in the community of faith. This was important also as a touchstone during the transition to remind people why the change was important.
- 3) Decision making was done in the context of the question of what is God calling us to do and what is the faithful response. Ensuring that decisions were in line with the congregations' values.

4) There was a focus on sharing the good news that people had discovered and inviting others to come and see.

This year has felt a little like we have been wandering through a hot and long desert. If you are feeling tired, that makes sense because walking on sand is hard. However, in the bible the desert is a transitional and transformational place. It is a place where people meet and experience God's presence and direction. The consultants from the Downtown United Project told us that the bottom of the change curve felt like this, although they used the metaphor of walking through mud. They also told us that if we held on and moved through the mud, we would gain clarity and get to the up swing/new life. At the end of 2023, after much wrestling and walking, a path started to emerge. In some ways, the timing of some events has felt like they have even been gifted to us. The work of 2024, at least from my perspective, is to lean into our renewing and strengthening faith practices, to discern and make concrete decisions on our direction, and then be the loving and compassionate community I know you are as we hold each other through the transition towards new life.

As we wrap up another year know this, when I think of you, the story of this congregation, the passion and gifts, the struggles and tenacity, the joy and hope, I give thanks. For you are the people of God, St. Paul's United Church, the people whom I am called to walk with through our laughter and tears, and YOU are loved, by God and by me.

As you read through this report, the words that tell the story of our ministry in 2023, I invite you to give thanks for all who have participated and been served by our congregation. I encourage you to remember that the church in action doesn't just happen, it is powered by the joy, sweat, and tears of people like you giving of themselves, and by God's spirit at work. As we head into the decisions that 2024 will bring, please pray for our congregation, its lay leaders, and myself, so that we may all pursue God's call, that call to be Deep, Bold, and Daring.







Treasurers Report

Congregational Board Report

This year has been a challenging year for the Board, in the most recent history, the Board had functioned not as a driver of the congregation but more as an oversight and reporting body. In 2023, the scope of the challenges faced by our congregation, and the reality that engagement patterns seen with COVID have not significantly changed, forced the Board to wrestle with considering the congregation's future. In January the Board had a weekend "retreat" to look at the dynamics that are affecting congregations today and looked at information about navigating change in congregations.

In January there was hope that progress was finally being made around the prospect of working with Kindred Works, as the congregation was invited to meetings to learn more about the organization and how they could potentially help us with our building concerns. A development team was appointed by the board. In the following months, it became clear that the project being suggested wouldn't adequately address the needs of the congregation.

There were concerns about the limited number of people on the Board, so the Board brought together the Trustees and other congregational leaders into what was called the Key Leadership Group, to ensure a more complete representation of the congregation was being heard as we develop a path forward. There is significant diversity around the table regarding what our situation is and what the possible solutions are. The Board accepted an invitation from Rev. Rose-Hannah to lead us in the process of building consensus around the challenges and feasible solutions. The results of these discussions were taken to Congregational meetings in October and November respectively. At the meeting in November, consent was given by the congregation to explore the process of divesting the building and entering an Ecumenical Shared Ministry with St. Andrew's Presbyterian Church.

The Board discussed its structure and representation, along with the need to permanently increase the number of people involved in our decision making. A draft framework was created to transition to a Council model. This document is still being worked on. This need was made even more critical as we said goodbye to Board members Erin Hayes and Donna Chauvin, who both moved away from Fredericton.

The Board received the final report from the Downtown United Committee in October. There were recommendations made for the Board to review and consult with Wilmot Council, however, this will be dealt with in the fall of 2024 when the path has been determined for divesting our Property and Ecumenical Shared Ministry options.

More than anything, the Board would like to thank everyone who donated their time and effort in 2023. It has been a year of big discussions and uncertainty, thank you for continuing your engagement. To keep our congregation going into the future, your participation on our committees, with our outreach programs, joining us at worship, and attending congregational meetings is vital. Ministers have told us that the Church is not the building but the people, now is our time to prove that right. Thank you for choosing to be part of the St. Paul's family.

Committee Reports

St. Paul's Trustees

The Trustees are responsible for managing the financial and physical assets of the Church, acting on behalf of the congregation. The financial assets include several Trust Funds and other accounts. The physical assets include the sanctuary, hall and two social housing properties.

Members and Structure. The Trustees who served in 2023 were Frank Goddard, Mary Jacobs, Carole Peacock, Lois Walker, Bill Paterson, Alanna Palmer, Mel McGuigan, Andrew Steeves, and Rev. Michelle Armstrong. Andrew presided over the Trustee Meetings as Acting Chair with Alanna acting as Secretary, keeping Minutes. The Trustees also had an Investment Sub-Committee responsible for the stewardship of St. Paul's financial assets. It was Chaired by Alanna with Bill and Andrew as the other members. The group met with the congregational investment advisor on January 19th.

Meetings. During the year the Trustees held face-to-face meetings and conducted several items through email correspondence:

- January 17th
- March 16th (with members of the Board)
- July 26th
- September 26th (with members of the Board and Property Committee invited)
- October 13th (with members of the Board and Property Committee invited)
- November 8th (with staff of City of Fredericton Planning Department)

Minutes of these meetings have been submitted as they have been approved by the Trustees.

It should be noted that, in addition to Trustee-led meetings, the Trustees were participants in several broader meetings involving:

- the Church Board (see above),
- the congregation (March 26th, October 15th, November 5th),
- the informal Leadership/Development group (October 30th, November 16th),
- Kindred Works (March 22nd), and
- the "Downtown United" initiative (Creedence consultants, January 17th, January 24th, November 26th).

Minutes and summaries for these meetings are submitted separately.

Vision. For several years the Trustees have been guided by a vision which the Trustees have called St. Paul's 250. In this Vision our Sanctuary, Hall and rental housing units are in excellent repair and in regular use when the church celebrates its 250th anniversary in 2082.

To fulfill this Vision, Trustees have been aware that St. Paul's physical assets must be supported with a solid financial footing coming from investment income and revenue streams. To this end, Trustees continued to work diligently and prudently on behalf of the congregation in 2023.

However, recent events have led the Trustees to consider a review of the St. Paul's 250 Vision as discussed below.

Activities in 2023:

- 1. **Repairs and Maintenance** A busy year, the Trustees and Property Committee have continued their efforts to keep the church's buildings in good condition. A significant concern has been the roof of the sanctuary. Despite a prolonged search, we have been unable to find a contractor to do the sanctuary repair. Fortunately, we were able to fund the rehabilitation of the George Street fire escape.
- 2. **Investments in good shape.** The sub-committee met with our investment advisor (January 19th) to review our investments and returns. The sub-committee's review affirmed our investment policy.
- 3. Transfer of Documents to the Archives of the UCC in Sackville on September 14th and November 9th.
- 4. Outlook Significant Concerns. Working with the Property Committee, Trustees viewed and discussed the future repairs and financial needs of St. Paul's properties. With the latest round of roof and bell tower repairs, the investment account would fall to about \$75,000. Furthermore, the church faced further major expenditures over the short and medium term. For example, the repair and rehabilitation of the York Street facade of the Sanctuary had been estimated at over \$1,000,000.

- 5. A Search for Solutions. Faced with these challenges, the Trustees, over the last 10 years, have investigated options to generate revenue for operations, repairs, and maintenance. In their latest search for a solution to our needs, Trustees and the Board have agreed to work with UPRC and its successor, Kindred Works (KW). However, KW had changed its operations and, as a result, is not a viable option for creating a revenue stream for the congregation.
- 6. **Meetings of the Board and Trustees.** In their effort to deal with the challenges, the Trustees have invited the St. Paul's Board to review the challenges our church is facing, including:
 - 1. a lack of reserve funds for maintenance,
 - 2. reduced financial resources available on our operating side (offerings),
 - 3. heavy demands upon our human resources (especially volunteers), and
 - 4. building maintenance and use while considering our congregational dynamics post-COVID.

Faced with these challenges, the Trustees, at its September 26th meeting, called upon the Board and the Region to respond to these concerns urgently. In response, the Board and Trustees, together with other involved members of the church family, formed an informal "Leadership Team" which has participated in a process facilitated by Rev. Rose-Hannah Gaskin, that has helped the team develop a path forward and plan for our congregation – a New Vision.

(Note: since the formation of the "Leadership Team" in the Fall, the Trustees have not held a stand-alone meeting. Since all Trustees are members of the Team and meet on a regular basis, they have conducted business before or after the "Team" meetings. In addition, the Trustees have responded to small items of business (expenditures below \$10 k) with motions and votes via email.)

Christian Education

Sunday School ~ Fall 2023 / Winter 2024

For our current Sunday School season, we have been utilizing the "Living the Word" teaching guide. This guide works very well as the lessons coincide with the weekly scripture readings and serve to reinforce the message from the sermons in a way that the children can easily learn and put into practice.

We meet weekly after the "Time for All Ages" portion of the Sunday service and go back to the classroom to discuss a simplified version of the scripture reading. This is followed by either an activity or a craft the children can participate in/make, which demonstrates the key takeaways from that week's lesson.

We currently have three children active in Sunday school on a regular basis, and although it is a small group, Sunday school is an important part of our church that provides a fun and welcoming space in which our youngest members can engage with scripture. We will continue with these lessons until summer break.

Adult Education

From January - May 2023 there was an adult bible study offered on Wednesday mornings. Starting in September we shifted this study to Tuesday morning from 10:45-11:45. This group has primarily used a Lectio-Divina pattern of looking at the scriptures where no experience is needed. In September there was interest expressed in an evening faith exploration and bible study. This group of primarily younger adults has been meeting since October on Thursday nights. This group explores faith practices, life, and scripture. Both adult groups are given a take hope resource for continued digging into the scriptures.

A small insert for home devotional God's Story our Story, was offered on Sunday Mornings for people to take to help them think about and go deeper with the scriptures and prayer.

Christian Education also supports the outreach and engagement with Campus Ministry. Supporting students at UNB and beyond. This year while the Campus Chaplain was preaching, the UNB Campus Ministry band shared their talents with us.



Property Committee

The Property Committee, our busy beavers, consists of: Kyle Mathers, Walter Bidlake, Brad Webb, Derrick Grant, and Ron Yateman. Although not part of our committee, you need to know that Meghan Roebuck and Rusty Blakely lighten the load for us.

2023 began with issues with the boiler causing the congregation to bundle up for services. Over the past year, the boiler continues to test us with one issue after another... we do not expect these issues to vanish although it is cared for daily and carefully by our custodian.

We have a new snow removal company to clean the parking lots and our staff continues to work with them to do the work the way we needed. Sanding will continue as part of the contract, but their company will be responsible for sweeping it in the spring.

We had a new leak by the elevator near Charlotte St. door. Walter did a temporary repair waiting for a professional to do a permanent repair in the summer. Over the year we have found more leaking in the sanctuary during the big storms we are having. However, Kyle has researched companies as far away as Ontario who would be capable of doing the repairs but has not found one who will even give us a quote. During the fall, we had as many as 6 leaks in the sanctuary during one storm.

During the summer of 2023, we had a student to help Rusty and learn some new skills. They took on the job of painting some of the interior doors. Along with Meghan, they were busy sorting several rooms full of unnecessary items.

Last fall, the fire escape leading from the sanctuary to George St. parking lot began to crumble in a big way.

Repair has been accomplished until replacement becomes imminent. And we had annual repairs to the concrete steps leading into the sanctuary on George St.

Rusty and Tammy Coughlan worked on keeping the rental houses shoveled: the fire escapes and wheelchair ramps free from ice. Before the summer was out, both wheelchair ramps collapsed... Walter to the rescue. He also found that we needed to replace a door on 242 York St. with rotting of the sills. This was contracted to be done. Also, we installed more eavestroughing on each of the rental buildings to better protect the wheelchair ramps and the fire escape. One of our windstorms removed many shingles from 230 York St. which have been patched waiting for a new roof in the summer.

Just for your information, we did have one incident of a broken basement window on York St. that was repaired immediately.

We continue to work to keep our church family home in good repair. Anyone who would love to join us is very welcome, even if it is to get quotes for jobs to hire or work with Walter to do repairs... always more fun with a partner.

Feel free to let us know of any issues you notice so we can address them.

As of January 1st, 2024, we have had a vacancy on our M&P Team as Blaine Irving has taken the position of Chair of the Board. We are looking for a 3rd member, perhaps a male, to join us in fulfilling our duties and responsibilities as M&P members. Thanks for considering this opportunity.

Community Outreach

The Pantry

Mission Statement: To assist needy families in our community by providing food, and household items to augment services they receive elsewhere.

As of December 31st, we have a total of 153 clients. This includes 243 children, 31 single women, 39 single men, 17 couples, 20 single parent families, 56 2-parent families. Most of these are immigrant families. They have between 4 and 8 children. When they come to Canada, they are given a home and some money but not enough to live on. It must be very difficult for them. Most of them do not speak English. Some are from Syria. A few can speak limited English. We also have 2 students from India.

The members of the congregation support the Pantry and Brown Bag lunches very well. One member gives us a \$50 gift certificate every month to a store where we buy most of our groceries. Several give through PAR.

All eleven volunteers in the Pantry appreciate every donation, large or small. We all thank you very much.

Brown Bag Lunch Program

I also look after the Brown Bag lunches. There have been as many as 18 people in one day coming for a free lunch. Many are homeless. I make up the bags and Meghan hands them out from the office. She records each bag she gives out. Throughout the year, 922 Brown Bag Lunches have been disseminated to 180 individuals.
